The Botswana Council of Non-Governmental Organizations (BOCONGO) was established in 1995 to coordinate the work of Non-Governmental Organizations (NGOs) in Botswana. With a total of 400 members across the country, BOCONGO has over the past 29 years created a platform for CSOs in Botswana to actively engage and contribute to processes of development planning and implementation, policy formulation and legal reform. Over the years, BOCONGO has facilitated capacity building of individual CSOs to be effective advocates and key contributors to the advancement of national priorities and programs. Working with its member organizations, BOCONGO has been spearheading engagement of the Constitution review process as far back as 2021.

ABOUT THE PETITION

That the petitioners, being members of civil society organizations and other individual citizens:

- a) Express significant concerns regarding the Constitutional Review process insofar as it has not been open, inclusive, and transparent.
- b) Oppose the Bill in its current form due to its total disregard for actualizing the aspirations of majority of citizens who participated in the review consultations.
- c) Oppose the Bill in its current form due to its deliberate attempt to undermine the doctrine of separation of powers and to further entrench Executive Overreach.
- d) Oppose the Constitution [Amendment] Bill, 2024 (BILL No. 4 of 2024) in its current form due to its failure to address crucial reform issues essential for democracy protection of fundamental rights and institutional independence.
- e) Express particular concern that hard copies of the Constitutional Review Bill were unavailable for purchase at the Government Printers for 14 days after its gazettement thus limiting the 30 days' public access to a bill before first reading in Parliament as required by law.
- f) Express serious concerns regarding the inadequate access and affordability of key constitutional review documents to its members and the public.

Wherefore your petitioners pray that your Honourable Assembly will;

Revoke the Constitution (Amendment) Bill, 2024 (BILL No. 4 of 2024) as it stands and refer it to the High Court of Botswana for a priori review – the Bill has some noteworthy and commendable aspects. However, in its entirety, it falls short of the recognition and realisation of rights that Batswana desperately need.

Therefore, we demand for the following from the Government of Botswana:

- A review of the Constitutional Bill and the process around the drafting of the Constitutional Bill due to its failure to meet in particular:
- The review process failed to properly and adequately obtain/ascertain the view of Batswana from various societal backgrounds;

- b. The recommendations agreed fail to properly articulate the concerns of Batswana through the proposed amendments; and
- c. The constitutional bill in its current form fails to adequately protect the promotion of people's rights, promote equality, national unity, and democracy.
- Continued and robust engagement with national and global civil society, nonstate actors and community organisations and Batswana at large.
- 3. An amendment of section 87(6) and 89(2) to make provisions for public participation and consultation processes throughout the constitutional review process. We advocate for the amendment of Section 89 to provide for a peopledriven process, thereby guaranteeing the right of citizens to actively participate in the formulation and amendment of constitutional provisions. (Guarantee the right to participate.)
- 4. Restart the process anchored on a Botswana Constitution Review Act. We call for the restarting of the constitutional review process, anchored on the enactment of a Botswana Constitution Review Act. Such legislation would facilitate a comprehensive and inclusive review process, guided by principles of transparency, inclusivity, and democratic governance.
